## Training and Development


The Council will support your training and development through:

- A comprehensive clinical supervision programme including an extensive in-house training programme and formal external training opportunities, 1:1 meetings with your line manager (weekly for NQPs for the first 3 months moving to monthly over the first year at your pace), participation in clinical effectiveness groups, case study groups and an NQP group, encouragement to join and attend CENs relating to practice, and a peer buddy.
